## Re: AOA Comments and Recommendations to Address Mandatory Sequestration Cuts

Dear Speaker Pelosi, Minority Leader McCarthy, Majority Leader Schumer, and Minority Leader McConnell:

On behalf of the more than 151,000 osteopathic physicians (DOs) and osteopathic medical students represented by the American Osteopathic Association (AOA) and undersigned specialty and state osteopathic associations and the patients they serve, we write to express our strong support for the passage of the bipartisan *Medicare Sequester COVID Moratorium Act (H.R. 315)*, to avert the 2% mandatory sequestration cuts to physician payments during the public health emergency. We also ask that Congress act to ensure that any Medicare cuts relating to statutory 'Pay-As-You-Go' (PAYGO) requirements be prevented.

On December 27, 2020, Congress recognized the growing economic toll COVID-19 has had on physician practices and passed a short-term sequester freeze until March 31, 2021. Our organizations appreciate this delay; however, the fight to defeat the pandemic continues and many challenges persist. Our country's healthcare system continues to face a severe financial strain due to the

COVID-19 pandemic. The continued toll that it is taking on small physician practices is a burden that many are struggling to navigate. These practices are foundational to patient access to primary care services and management of chronic conditions. For patients with chronic conditions in particular, access to their physicians is essential to maintaining wellness.

To better understand the effects this is having on our membership, the AOA conducted a nationwide survey of practicing DOs last year to gauge the financial toll COVID-19 is taking on their practices. Of those who participated in the survey, 95% of physicians experienced a decline in practice revenue due to COVID-19, and more than 40% experienced a cut greater than 50%. The essential takeaway is that that physicians across all specialties are struggling to keep their practices open due to increased expenses and reductions in revenue as a direct result of the pandemic. Perhaps the most important takeaway from the survey is that 75% of physicians said that even after receiving either a Department of Health and Human Services (HHS) provider relief payment or Small Business Administration loan, they still need financial support to be able to continue providing quality patient care.

These increased financial challenges are especially difficult for small physician practices in rural and underserved communities across the nation, and further reinforces why a 2% sequester cut would be devastating and dramatically impact our physicians' ability to care for their patients. Medicare sequestration cuts would also disproportionately affect osteopathic physicians and the patients whom they serve given that DOs make up 11% of all physicians in the United States and comprise 40% of the physicians practicing in medically underserved areas.

One of the issues highlighted by the pandemic is the limited access to essential medical services that plagues underserved communities, which is exacerbated by physician workforce shortages. Beyond access to testing, treatment, and vaccination for COVID-19, there is an ongoing need to increase access to physician-led care for primary care, mental health, and substance use disorder treatment services for all populations, and especially in underserved communities.

Even with the encouraging development of an effective vaccine, physician practices will continue to face overwhelming financial challenges and pressures associated with higher overhead costs. This includes, but is not limited to, new investments in infrastructure, increased personal protective equipment (PPE), and other essential medical supplies necessary to safely vaccinate and treat patients.

Physician practices are currently facing significant economic hardships. Allowing sequestration or PAYGO cuts to physician payment to take effect would further strain Medicare beneficiaries access to care in rural and underserved communities.

We greatly appreciate the work that Congress has done to support our nation's recovery from this pandemic and request your assistance in addressing this critical issue to improve access to care for all Americans.
