Three Easy Steps to Receive Your CME Credit

1. Sign in at the registration table. (Look for the balloons.) You only need to sign in once during the entire Symposium.
2. Print your name clearly and indicate your AOA member number on the CME Verification Request Form to receive credit.
3. Complete the CME Verification Request Form (with your AOA number and email address). Indicate only the number of hours you attended, sign at the bottom and turn in with your evaluation packet at the Registration Desk before you leave. If you forget to submit it before leaving, you may fax the form to 740.593.9536.

Physicians must complete the CME Verification Request Form attesting to the total hours attended. A certificate of attendance will be emailed or mailed to you approximately four weeks after the Symposium.

J.O. WATSON, DO, MEMORIAL LECTURE: ADVANCED RESEARCH IN ALZHEIMER'S AND MILD COGNITIVE IMPAIRMENT

Robert Nagele, PhD, and his research team at Rowan University School of Osteopathic Medicine in New Jersey have developed a groundbreaking blood test that can be used to diagnose Alzheimer's disease with 96 percent accuracy. In addition to being the first blood test for diagnosing the disease, it is also less invasive, less expensive and more accurate than previous tests. Until Nagele's breakthrough, there had been no accurate or reliable test to diagnose early Alzheimer's disease.

Nagele was selected to deliver the annual lecture, a prestigious, long-standing tribute to one of Ohio's most respected DOs. J.O. Watson served the profession for more than four decades until his death in 1985. The award honors individuals who have made a significant contribution to the advancement of health care, osteopathic medical education or research. Thanks to the generous support of the Osteopathic Heritage Foundations, the lecture award carries an honorarium as well as a \$5,000 charitable contribution in the recipient's name to an osteopathic-supportive endowment, college, university or foundation of the lecturer's choice.


